The GTFCC Cholera Research Tracker

Introduction

Thank you for taking the time to fill out <u>this form</u>. The aim is to collect information on active and recently completed research projects that focus on generating knowledge or evaluating interventions which may be used to inform or improve cholera prevention and control efforts. Active = projects which have received funding and are currently ongoing or about to start; recently completed = projects which are finished/published within the last 5 years. **We are not collecting research project data, results or budget information**. Please enter as many cholera-related research projects where you are the lead or co-lead as you have time to submit, with preference given to active research projects.

The information collected in this form will be used to populate an interactive database and dashboard called the Cholera Research Tracker (under development) which will be publicly available on the GTFCC website for everyone to view, search and export. This form will be available between March – June 2021, please aim to submit research projects by the 24th May. We expect to launch the Cholera Research Tracker in June 2021 at which point you will be able to submit research project information directly on the GTFCC website on an ongoing basis and there will be a dedicated contact point available for updating entries. The short-term goal for collecting and making this information public is to create better awareness of the breadth of ongoing cholera control research projects. Longer-term, the Tracker may be used to help support collaborations and to analyse research trends in order to identify knowledge, activity and funding gaps.

After submission, projects will be reviewed by the GTFCC Secretariat and the Wellcome Trust to standardize data entry and code entries to enable search functions. Individuals will be informed when projects have been added to the database. If the same research project is submitted twice (by Co-Investigators or Collaborators), entries will be aligned and combined as part of the review process and individuals will be contacted for more information if necessary. Please ensure that all named collaborators have agreed for you to share their details with us, including for their names to be published on the research project listing page.

How we're defining research: projects which seek to gain new or improved knowledge, evidence and understanding. Examples include (but aren't limited to) discovery science; clinical trials; community engagement and social science research; systematic reviews and meta-analyses; monitoring and/or evaluating the use, uptake or effectiveness of interventions on any aspect of cholera disease burden including health, social and financial. When in doubt, please submit and we'll contact you if we have further questions.
