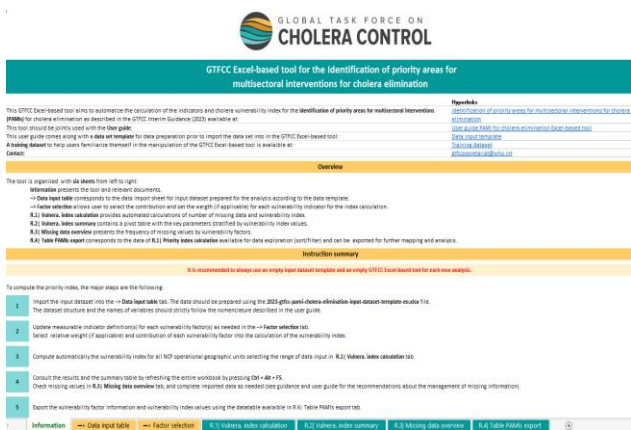

Template report on the identification of PAMIs  
for cholera elimination

- I. Background**
- Information on any previous identification of PAMIs (method, analysis period)
  - Information on MCP status and targets (past, current, and future) in the country
  - Concise description of the cholera epidemiological situation in the country and cholera control efforts in recent years (up to last 10 years)
  - Concise description of cholera surveillance system
  - Concise description of cholera testing strategy
  - Justification for using the method "PAMIs for cholera elimination" (i.e., provide percentage of MCP operational geographic units with confirmed cholera outbreaks consistently over the past five years)
- II. Methods**
- Supporting information**
- Administrative level of MCP operational geographic units
